8. On 062013 at 1540 hours I assisted Portland officers with a call that had occurred at the intersection of SE 82/ SE Powell near the bus stop. I was advised via dispatch that a subject with a gun flashed his gun at two Tri-met bus drivers that were standing near the bus stop waiting for their bus to pick them up. I arrived on scene and took the two bus driver's statements.

I first spoke with and identified the male bus driver by his Oregon Driver's license as Daniel Martin. Martin had told me that as he was waiting at the bus stop for his bus (in Tri-met uniform) he was approached by a frantic subject that started yelling at him to call the police because someone had just threatened him with a gun. This subject was later stopped and interviewed by Officer Declerque, see his report for further. Martin said that he told this subject to use the pay phone and call 911 because he didn't understand what the subject was referring too. Martin then said that the male went around the corner to the 7 Eleven located just east of the bus stop and then a different subject came running around the corner holding a gun and as he was walking in Martin's direction, he pointed the gun towards Martin and told him to get out of his way. Martin then said that the first subject that told him to call 911 came running around the corner as if he was chasing the subject with the gun and continued to chase the subject with the gun until Martin lost sight of both of them as they continued north on SE 82nd Ave. Martin then said that he called 911 and stood by for police contact.

I then spoke with and identified the female bus driver by her Oregon Driver's license as Christina Castaneda. Castaneda had told me that as she was waiting at the bus stop for her bus (in Tri-met uniform) she saw an unknown male subject sitting on the steps near the bus stop being obnoxious, loud and

unpleasant to be around. Castenada then said that this subject left the steps where he was sitting and went around the corner near 7 Eleven. Castenada then told me that the next thing she remembers was that same subject coming towards her and Martin and was screaming at Martin to call the police because someone had just pulled a gun out on him. Castenada said that the male went back as if to walk back over to 7 Eleven and then another male came running towards her and the rest of the people waiting at the bus stop and he was holding a gun pointing the gun in the direction of the group that was waiting at the bus stop. I asked Castenada if it appeared the man with the gun was pointing the gun directly at her or just sweeping the group as he ran in the group's general direction and Castenada told me that it appeared the man with the gun was sweeping the whole group with the gun as he was trying to run past them. Castenada then told me that she jumped on board Tri-met bus #2306 and left northbound on SE 82nd Ave.

The subject with the gun was described by both Martin and Castenada as a white male between 20-30, facial hair, about 5'08, 180-200lbs, wearing a two toned black/grey jacket over a green shirt and blue jeans.

I requested for a Datapack to be pulled off bus #2306.
